#### a. Melissa Head of School Report

Enrollment updates for current enrollment and re-registration was shared for all three schools.

Student Enrollment: CVA 941, ORDCA 120, and ISORPH 287. At the time the report was pulled total student count was 1348.

School District Denials are starting to impact students able to come to our schools. We had 121 current students who applied for semester 2. Students were not approved for enrollment due to their Resident School District cap of 3%. We are reaching out to each

of them to support them in filing an appeal.

Melissa is involved with the Legislature regarding the 3% District cap. She is challenging the timeline of when they are counting the cap: end of last school year or current.

Today is the first reading for all Board Policy Updates presented and previously sent to the Board for review. Most of these are existing policy updates and have minor punctual updates.

One new policy is being presented. IL G1: Assessment Program. This is a new policy in the state. Details were shared out with the Board.

This spring it was approved by the State Level State that Smarter Balance Spring Assessments can be proctored virtually. This is a big change and is exciting for us as school for several reasons; testing site reservations, increase accessibility to all students, potential increase for more students to test. These changes will positively impact our goal to reach 95% or higher for all students tested. Our staff are already trained in how to

proctor testing virtually.

Next month all policies updates will be an action item.

Last night at the Mitchell School District Board meeting they agreed to approve all three Charter School Renewals through 2030. We are excited about this extended time to grow enrollment and show growth in our programs in all schools.

There are two documents for each school that will be presented as an action item; Charter Contract Amendments for CVA/ORDCA/ISOR-PH and Renewed and Amended Charter Contract for CVA/ORDCA/ISOR-PH. These Contract and Amendment updates show the financial changes Mitchell SD has requested and the new extended contract end date. The changes will be backdated to July 1, 2021 and will be in effect through June 30, 2030.

We are very excited for this extended time to partner with Mitchell School District.

We are presenting a revised Employee Agreement Amendment to reflect the Board's decision to pick up the Employee's required 6% contribution to PERS effective January 1, 2022. Employees will no longer contribution to the Employee portion. This is an action item.

Out of state employees who have met their contribution start date with PERS are now eligible for contributions. This new law, PERS SB 111A, went into effect January 1, 2020. As a result of this law, the school will pay a school contribution of \$109,179. It is recommended that the Board pick up the total employee contribution as well due to several staff no longer with the school. The challenge to collect these contributions from current and past employees would be difficult. The recommendation is for the Board to pay the employee contribution as well for these staff. The total employee portion is \$18,761. Total of \$127,940 to be paid by the Board for all out of state staff to catch up.

# C. Finance – Sarah Olivas

Sarah presented the January K12 Finance report.

Overview and Key Assumptions FY22 P & L Forecast vs. Budget FY Restricted Funds Balance Sheet Cash Flow

Overview and Key Assumptions

Enrollment is lower by 678 students as compared to Budget (-35%). Revenue is (\$6.3M) (-33%) lower vs, Budget Expenses decreased by (\$7M (-31%), primarily due to reduction in CFA positions and alignment to ratio, as a result Deficit is improved by \$650K.

Decrease of enrollment by school:

Total -748

ISOR-PH -499 ORCVA -83 ORDCA -166

## FY22 Budget vs. 6 + 6 Forecast

Revenue decreased by (\$6.4M) due to lower enrollment of -748 students resulting in 1,402 total overall student enrollment. Due to lower costs for salary, benefits, curriculum, materials, computer, testing and related services expenses. Increased costs for higher liability insurance and increased cloud storage. Overall Deficit improved by (\$650K). K12 issued (\$650K) to balance the budget.

# FY22 Prior Forecast v. 6 + 6

Decreased due to lower enrollment. This has been impacted by the \$88K increase in PERS contributions, \$127K retroactive out state PERS contribution and \$18K related staff expenses (PD, Travel, Supplies). Increased Administration and Governance for Academic Advisor positions added (offset by ESSA partnership Funds) K12 to issue \$555K to balance budget.

Chet Edwards inquired how we are doing and how we are navigating the lower enrollment numbers and consequent revenue. Sarah replied we have had some curve balls thrown in the PERS this year, but Melissa is doing a great job of mitigating expenses to cover these costs and we are looking at where we can reduce spending.
